POLICY INFORMATION IAW
DSAA MESSAGE 091653Z MAR 98,
SUBJECT: 9 FEBRUARY MEETING AT DSAA ON TRAINING CANCELLATION FEE
POLICIES. THIS INCLUDES A LISTING OF COURSES SUBJECT TO A 100 PERCENT PENALTY
FEE.

2. EFFECTIVE 1 OCTOBER 2000 THERE WILL BE A 100 PERCENT PENALTY FEE (UNLESS QUOTA IS
FILLED BY ANOTHER
INTERNATIONAL STUDENT) FOR CANCELLATION OF CERTAIN COURSES WHICH RELY ON CONTRACT SUPPORT
OR WHICH
ARE DESIGNATED FOR INTERNATIONAL STUDENTS ONLY. THIS COURSE LIST IS REVISED AND
PUBLISHED AT THE
BEGINNING OF EACH FISCAL YEAR. THE 100 PERCENT CANCELLATION FEE WILL APPLY ONCE A
CONTRACT IS LET OR A

3. FOR ALL TRAINING THAT IS PART OF A SEQUENTIAL PIPELINE THAT A

4. WHEN INTERNATIONAL MILITARY STUDENTS (IMS) ARE ATTENDING TRAINING AT DLIELC AND
FAIL TO MEET THE LANGUAGE

REQUIREMENT FOR FOLLOW-ON TRAINING, PENALTIES WILL BE ASSESSED AS FOLLOWS:

A. 100 PERCENT PENALTY FOR ANY FOLLOW-ON DEDICATED/CONTRACT
COURSES INCLUDED IN THIS MESSAGE.

B. 50 PERCENT PENALTY FOR ANY FOLLOW-ON QUOTA CANCELLED LESS
THAN 60 DAYS PRIOR TO SCHEDULED COURSE START DATE.

5. DEPARTMENT OF THE ARMY WILL DETERMINE PENALTY CHARGES FOR OTHER ARMY TRAINING NOT
INCLUDED IN THIS

MESSAGE. OTHER TRAINING THAT INCURS UP-FRONT COSTS PRIOR TO BEGINNING MAY ALSO INCUR A
100 PERCENT

PENALTY FOR CANCELLATION. THE CUSTOMER WILL BE ADVISED OF
